





# On-going

- Annualizing blower replacements (\$15k / year)
- Locate services contract support

### **MANDATES**

- Facilitate operation and care of the waste water treatment plant system which ages daily AND must function  $24\ /\ 7\ /\ 365$
- State permit obligations
- Aging equipment replacement
- Increases in rain events
  contribute to I&I and
  warrants investigation and
  a strategy to seal system
  (= operating cost savings)



## **CARRY OVER**

- Inflow & Infiltration program development and deployment
- UV System replacement: Required of permit, failure of system will violate our operating permit
  - System is 25 years old and overdue for replacement
- Mobile pump unit acquisition
